Marlins Fees Conditions

Fees are due on the first day of each term - January, April and September. However, allowance has been made for payment to be made by the 28th of the first month without penalty.

Members are expected to pay the fee for the group their children belong to, as per the table below. Members benefitting from discounts or special arrangements should ensure that the fee payable is clarified with the treasurer.

Age Group	Fee
10 & Under	\$9,500.00 per term
Over 10 years	\$10,500.00 per term

Family Discount

The Family discount scheme caters to families with two or more swimming members. Such families will be entitled to a 10% discount off all club fees.

Joining Club Mid term

Fees will be pro-rated for payment based on the number of weeks remaining in the term.

Late Fees

Parents will receive a reminder if Club Fees are not paid by the 28th of the first month of the term. Thereafter, if payment is not made or an arrangement is not in place and agreed on by the treasurer, in consultation with the president, the swimmer will not be allowed to practice or enter subsequent swim meets until all outstanding club fees are paid.
